The attention of the Principals of APSWR Institutions is invited to the subject cited. In the reference 2nd cited the Government have issued orders duly extending the Revised Pay Scales-2015 to all regular employees working in APSWREI Society. (copy enclosed)

Therefore, the following instructions are issued to the Principals of APSWR Institutions/DDO's for implementation of Revised Pay Scales-2015 to the Society Regular employees working in their control:

Staff working at APSWR Institutions	Principal, APSWRS/JC concerned	The Principals are authorized for issue of Pay Fixation Proceedings to the Regular Teaching, Non-Teaching & Class-IV employees working in the institution. The Principals should submit Pay Fixation Proceedings, statement of arrear bills along with Service Books to the District Audit Officer, State Audit Department of concerned districts for certification in Service Register and arrears claims.
Principals of APSWR Institutions, Zonal Officers & Zonal Office Staff	Additional Secretary APSWREIS	Additional Secretary is authorized for issue of Pay Fixation Proceedings to the Principals of APSWR Institutions, Zonal Officers & Zonal Office Staff in the State. The Zonal Officers concerned stationed at Head Office will process the above RPS-2015 files to the Addl.Secretary. The Principals of APSWR Institutions should obtain Certificate from the District Audit Officers of State Audit Department in Service Registers confirming the RPS-2015 pay fixation orders issued by the Addl.Secretary and statement of arrears bill.
Society Head Office Employees	Additional Secretary APSWREIS	Additional Secretary is authorized for issue of Pay Fixation Proceedings to all Regular Employees working in Society Head Office. The Accounts-I Section of this office will process the Head Office Staff pay fixation files through the Asst.Secretary(Finance).

Further, the Principals are directed to submit RPS-2015 arrears bills to the Society Head Office duly obtaining a certificate from the District Audit Officer, State Audit Department of the concerned district for release of budget under Part-III of cash part.

Further, in the reference 3rd cited this office has addressed a letter to the Director, State Audit Department, Ibrahimpatnam, Vijayawada with a request to give necessary directions to all the District Audit Officers of the concerned districts to certify the Pay Fixations and arrear claims of Society Employees working in the districts duly recording the certificate in the Service Books as done in RPS-1993, RPS-1999, RPS2005 & RPS-2010. Further, the Principals of APSWR Institutions and Additional Secretary of APSWREIS are directed to go through the Orders issued by the Government from time to time for implementation of RPS-2015 and other allowances. And record the pay fixation entries in Service Register of the individuals properly.

The Finance Officer is directed to implement the RPS-2015 by revising RPS-2015 Pay Scales in HRMS Pay Roll Package immediately and release the arrears amount from the budget available with the Society.

ORDER:-

Government in the G.O. 1st read above, have issued orders for the implementation of Revised Pay Scales, 2015 for the State Government employees. The Andhra Pradesh Social welfare Residential Educational Institutions Society is an autonomous body constituted by the State Government for the administration of Social Welfare Residential Educational Institutions located all over the State with 100% Grant-in-aid. The scales of pay applicable to the Government employees are also made applicable to the regular teaching, non-teaching and Class-IV staff working in the Society.

2. The Secretary, Andhra Pradesh Social Welfare Residential Educational Institutions Society in the reference 2nd read above has requested the Government that the Revised Scales of Pay, 2015 may be made applicable to the regular teaching, non-teaching and Class-IV staff of the Society as was extended in the case of Revised Pay Scales of 1993,1999, 2005 and 2010.

3. Government after careful examination of the matter, hereby direct the Secretary, Andhra Pradesh Social Welfare Residential Educational Institutions Society, Guntur to make applicable the Revised Scales of Pay 2015, to the regular teaching, non-teaching and Class-IV staff of Andhra Pradesh Social Welfare Residential Educational Institutions Society, including the regular Head Office staff of the Society, as indicated in the Annexure enclosed to this order.

4. The additional expenditure on the implementation of the Revised Scales of Pay, 2015 to the regular teaching, non-teaching and Class-IV staff, including the regular Head Office staff of the Society should be met by way of re-appropriation from the overall savings of the Social Welfare Demand.

5. This order issues with the concurrence of Finance (HR-IV-PC) Department vide their U.O.No.33024/34/HR.IV-PC/2016, dated: 21-11-2016.
